**Revenue History by Area (Jan. - Mar. 2018)**



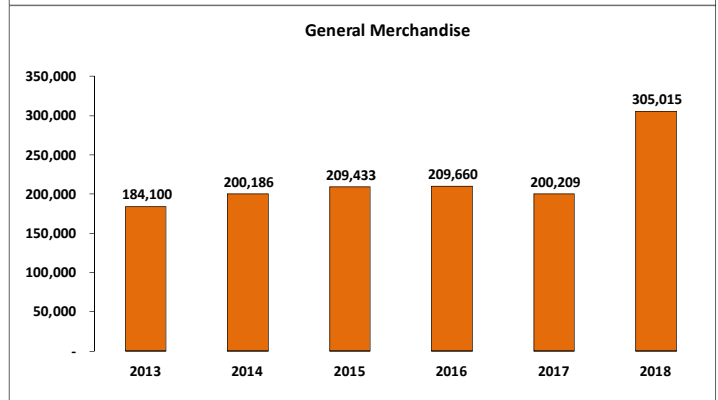
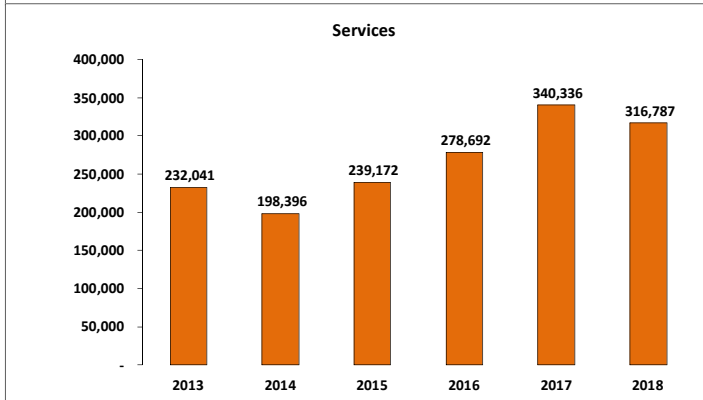
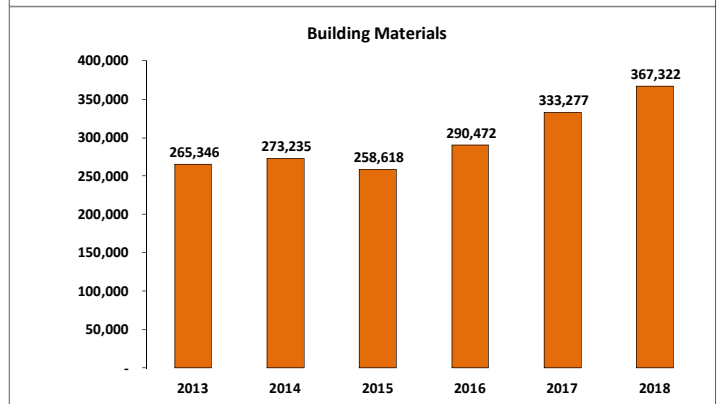
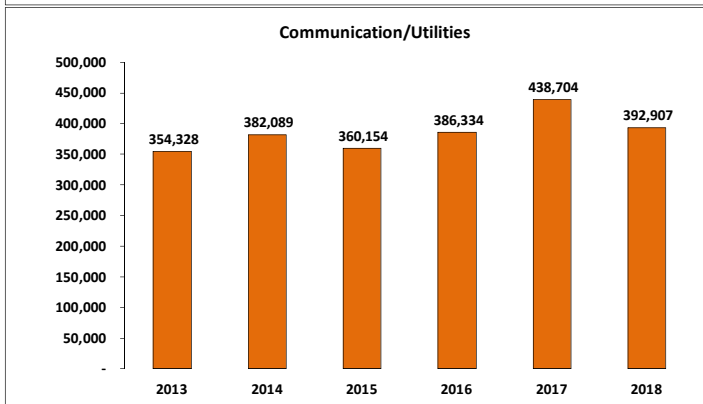
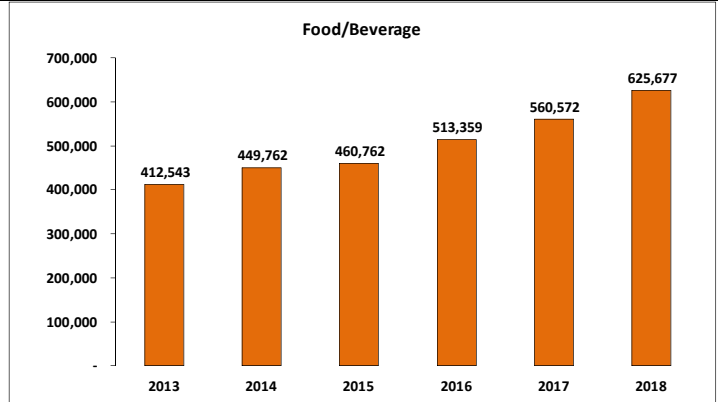
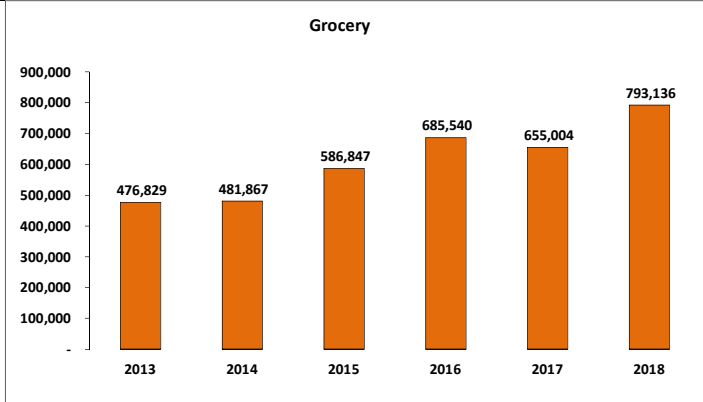
