Call to Order – Chairperson Machado called the meeting to order at 7:00 p.m.

Approval of Agenda – Chairperson Machado called for changes to the agenda. Lipton made a motion to approve the agenda. Carlson seconded. All in favor. Absent: Watson and Kaufman Agenda approved.

Machado called for any changes to the consent agenda. Brown moved the consent agenda be approved. Carlson seconded. All in favor. Consent agenda approved.

Authority Business

- A. Public Hearing – New Retail Marijuana Store – Little Lemon LLC d/b/a Little Lemon – 1655 Courtesy Road

Chairperson Machado opened the public hearing. Secretary Hanson reported the State Marijuana Enforcement Division reported no concerns in the applicant’s background check. She noted the State Marijuana Enforcement Division had issued a license to the applicant conditioned on local approval. This hearing had been posted and published in accordance with State law, the application was complete and she saw no reason for denial of the application.

Machado asked for any Authority disclosures and hearing none, moved the entire application be made a part of the record, Carlson seconded. All in favor.

Machado called for an applicant presentation. Adam Stapen, attorney for the applicant and Chelsea Duckham, applicant living at 1638 N. Emerson, Denver, CO introduced themselves to the Authority and Ms. Duckham took the oath.

Mr. Stapen had Ms. Duckham answer several questions concerning this application and business. Ms. Duckham reported she graduated from CU in Boulder with a sociology degree. She went to work for Pillows.com and moved quickly through the ranks of that company. She noted a prior colleague of hers has been in the marijuana business and she was interested after seeing her mom get relief from arthritis and her dog also had seen some benefits from CBD for anxiety. The business is named after her dog.

Ms. Duckham was excited to be part of Boulder County. She chose the location because of the availability and the traffic area. She noted it is currently an auto body shop. Construction will be necessary to complete it as a retail marijuana store. Reception area will be open and identification will be required to enter the store. The store is then in a loop so they will have identification checked again before exiting. Behind the counters will only be employees. Security cameras will be at every entry. No vertical licenses or id's will be accepted.

Ms. Duckham noted it will be about six months before the store can open. There is construction and a zoning issue that needs taken care of.

Machado asked if the applicant was familiar with software that scanned licenses and kept track of purchases. Duckham reported she would implement that. Machado asked about the zoning issues. Attorney Culley noted there was a Planned Unit Development (PUD) on the property that would need amended to allow for this use. She noted the Authority could approve with conditions that the PUD be worked out and a certificate of occupancy be received.

Brown noted having a brand new marijuana store licensee gave him some pause. He asked what assurance the applicant could give that she could run it in a responsible manner.

Ms. Duckham stated she has former colleagues who have experience in the business and she will have their help. She will only hire experienced people. She has managed people for a number of years.

Carlson asked if Ms. Duckham would still work for Pillows.com. She noted she will be concentrating on running the retail marijuana store.

Machado asked if anyone wished to speak for or against the application. Hearing no comments, he called for any closing remarks.

Mr. Stapen thanked the Authority and noted he understood Mr. Brown's concern. He noted it is a highly regulated industry and does not require prior experience to

get licensed. He said Ms. Duckham's background is clean and he hopes she will not be before the Authority for any problems.

Machado closed the public hearing and called for Authority discussion and comments.

Brown said it does give him pause to have an applicant with no experience running this type of business but understands that is not a reason for denial.

Machado noted he feels the applicant will work hard to run this business well. He stated there had not been issues with the marijuana businesses in town and he expects the same here.

Sergeant Redard noted the proximity to a liquor store and cautioned the applicant to be vigilant about that. Machado agreed.

Carlson moved the Local Licensing Authority of the City of Louisville find the applicant is of good moral character and all City and state law requirements have been met and, based on these findings, the Local Licensing Authority approve issuance of a Retail Marijuana Store license for Little Lemon, LLC doing business as Little Lemon. Machado seconded.

Machado offered friendly amendment the issuance of the license be conditioned on the applicant receiving a certificate of occupancy and all zoning approvals.

Motioner and seconder accepted the friendly amendment.

Roll Call Vote: Machado – yes, Brown – yes, Carlson - yes and Lipton – yes.

- B. Change in Ownership Structure – Compassionate Pain Management LLC d/b/a Ajoya – Combined Retail/Medical Marijuana – 1100 W. Dillon Road

Machado called the item. Lipton moved the change in ownership structure be approved. Carlson seconded. All in favor.

- C. Discussion/Direction – Fee changes

The Authority was asked to review a proposed fee change adding five percent to application fees. The State regulates the amount that be charged locally and Louisville has been far below that for some time. Lipton moved the Authority recommend Council go ahead with the proposed fee increases. Carlson seconded. All in favor.

Police Department Reports

A. Incident Report – Mudrock’s – 2/17/19

Chairperson Machado summarized the incident. He noted the State Liquor Enforcement Division helped with the investigation. The State alleged four violations, serving to a visibly intoxicated person, denial of access to records, allowing a visibly intoxicated person to stay on the premises and lying about ability to find the receipts.

Authority members discussed the incident and whether there was reason to order a show cause hearing.

Lipton moved the Authority order a show cause hearing on all four alleged charges for the August 26, 2019 meeting and appoint a special prosecutor. Carlson seconded. All in favor.

B. Incident Report – Henry’s/Tilt – 6/14/19

Chairperson Machado summarized the incident. There was a fight in the street between the two establishments. Sergeant Redard remarked if this had been called in at the beginning it may have avoided the escalation. Lipton asked who made the call to the police. It was determined it was the bouncer at Henry’s.

Brown moved to order a show cause for Henry’s for failing to report a disturbance. Carlson seconded. All in favor.

Carlson moved to order a show cause for Tilt for serving a visibly intoxicated person. Brown seconded. All in favor.

Authority members decided to hear these September 23, 2019.

C. Incident Report – Por – 7/6/19

Machado reviewed the incident. A patron had been refused service at Huckleberry and he went across the street to Por and was served alcohol.

Lipton moved to order a show cause hearing for Por serving to a visibly intoxicated person on September 23, 2019. Carlson seconded. All in favor.

D. Incident Report – Lulu’s/Waterloo/Henry’s – 6/17/19

This incident involved a couple drinking at Waterloo and Lulu’s and ending up at Henry’s. Sergeant Redard noted the female had a very high blood alcohol count. Lipton moved the Authority a show cause hearing for Henry’s serving to a visibly intoxicated person. Brown seconded. All in favor.

Secretary’s Report

Hanson noted the attendance at the June 23, 2019 seller/server training.

Sergeant Redard told the Authority the Street Faire attendance has been down a bit and there have not been any issues requiring action from the police department.
