Call to Order – Chairperson Machado called the meeting to order at 7:00 p.m.

Roll Call was taken and the following members were present:

Approval of Agenda – Chairperson Machado called for changes to the agenda. Brown made a motion to approve the agenda. Kaufman seconded. All in favor. Absent: Lipton, Carlson, Watson. Agenda approved.

Approval of Meeting Minutes – 08/26/19 – Machado called for any changes to the minutes. Kaufman noted a change that needed to be made and then moved to approve the minutes. Brown seconded. All in favor. Minutes approved.

Machado called for any changes to the consent agenda. Brown moved the consent agenda be approved. Kaufman seconded. All in favor. Consent agenda approved.

Authority Business

- A. Show Cause Hearing – KCM Restaurant Holdings LLC d/b/a Mudrock’s Tap and Tavern – 585 South Boulder Road 2/17/19
- B. Show Cause Hearing – KCM Restaurant Holdings LLC d/b/a Mudrock’s Tap and Tavern – 585 South Boulder Road 7/6/19

Special Prosecutor for the Authority, Adam Gollin, and attorney for the licensee, Dan Carr introduced themselves to the Authority.

Mr. Gollin noted there was a stipulation to present to the Authority involving both orders to show cause. The proposal on the first order is the licensee admit to the

violations concerning having records available and the other charges will be dismissed. The second show cause order would be dismissed. The liquor license would be suspended for 10 days with 5 held in abeyance. Employees would need to attend training in the next 60 days and the licensee may apply for a fine in lieu of suspension for the 5 days. There were 4 days held in abeyance on the last agreement, which will now be served as active suspension November 25 – 28, 2019.

Machado wanted to know how this type incident would be addressed in the future. Mr. Carr noted the establishment has provided video and information to the police department since the first incident and will continue to do so in the future if requested.

Brown noted his reservation about renewing this license at the last meeting due to the seriousness of the show cause orders and hoped to not see the licensee here on this type of matter again.

Brown moved to accept the stipulation as written, Machado seconded. Roll Call Vote: Brown – yes, Machado – yes, Kaufman – yes.

Mr. Carr noted he would submit the calculations for the fine in lieu along with the petition to the Authority secretary for consideration at the October 28 meeting of the Authority.

C. Show Cause Hearing – Hei Han Enterprises Inc. d/b/a Henry's –
Tavern Liquor License – 935 Pine Street – 6/15/19 Incident

Special Prosecutor Gollin noted he thought Mr. Yen, owner of Henry's, wanted to go to hearing without an attorney. The Authority confirmed with Mr. Yen that he wished to go to hearing without his attorney.

Chairperson Machado called the show cause hearing to order.

Mr. Gollin noted he was ready to proceed. Chairperson Machado noted Henry Yen was present and intended to proceed without an attorney. Machado confirmed this with Mr. Yen.

Mr. Gollin asked the Authority to take judicial notice Mr. Yen was here as owner and represented himself as holder of the liquor license. Machado noted the Authority took judicial notice.

Machado made the show cause notice a part of the record.

Mr. Gollin called Jerimiah DeHerrera to the stand. DeHerrera noted he is a Louisville police officer. He noted he was an officer on June 15, 2019, the date of the incident.

 Officer DeHerrera took the oath and testified he was dispatched to a fight on Pine Street which runs between Henry's and Tilt. When police arrived a few individuals scattered. One individual was placed in custody and detained near Pine and Main. People were running in the street and officers were stationed throughout the downtown area. Four individuals were charged with a variety of crimes. After detaining one individual Officer DeHerrera talked to the reporting party, the bouncer at Henry's. Two individuals attempted to provoke someone to fight at the rear entrance of Henry's. The bouncer asked them to leave but they kept trying to sneak back in.

The bouncer reported one of the individuals he asked to leave was trying to fight during the course of the night. He watched that individual leave Henry's and engage two unknown individuals in a fight in the street.

Prosecutor Gollin reviewed the incident as reported in the police reports. Officer DeHerrera reported one of those involved had hidden out on a rooftop and then came back and approached the bouncer. The bouncer had not called the police at this point. A female in the street tried to intervene and was swung at with a knife by a person who later fled the scene and tried to enter a home and then did enter another home nearby. He was faced by the resident of the home with a firearm. The intruder exited.

One of the persons involved in the fight went to the hospital with lacerations to the head.

Officer DeHerrera initiated a liquor investigation after the incident. He met with the bouncer at Henry's and the bouncer reported it was not Henry's policy to call the police until everyone was on their way out.

Mr. Yen noted the bouncer did call the police.

Mr. Gollin noted this hearing was about failure to report. The bouncer did kick out some of those involved. Had the bar reported earlier perhaps the fight would not have gotten to the point it did. He reviewed the intensity of this fight. Had the police been called this might not have happened. He said it was concerning the bouncer reported it was policy to get the persons out of the bar not necessarily reporting.

Mr. Yen said he tells his staff to report fights to the police right away. He noted he will discuss a policy to report right away with his staff. He stated the municipal court dropped the case against the bouncer for failure to report.

Hearing closed. Machado called for Authority questions or deliberation.

Machado commented this was a serious incident. He noted there is a question of what raises the incident to the level of a disturbance that needs reporting. He felt earlier reporting could have tempered the fight.

Brown noted the lack of a policy to report disturbances and was encouraged to hear the owner is looking to remedy that.

MOTION: Brown moved sufficient evidence had been presented to support the following charges stated in the Show Cause Order:

Louisville Municipal Code § 9.22.050, stating that any licensee shall immediately report to the City police department any unlawful or disorderly act, conduct, or disturbance committed on the premises and that the Authority Attorney be directed to prepare a draft of final findings, conclusions and an order for consideration at the Authority's next meeting to be held on October 28, 2019 and further moved to continue this matter until that time.

Kaufman seconded. Roll Call Vote: Kaufman – yes, Brown – yes, Machado – yes.

Machado noted at the next Authority meeting there will be findings and order for the Authority to consider along with a penalty. The Authority will also consider any aggravating or mitigating circumstances when considering the penalty.

Machado noted the next item to be considered would be Item E concerning Tilt.

E. Show Cause Hearing – Tilt III LLC d/b/a Tilt – Lodging and Entertainment Liquor License – 640 Main St. - 6/15/19 Incident

Mark Oberholzer, owner of Tilt, introduced himself to the Authority. Mr. Gollin noted the City wished to withdraw this show cause order as he felt there was not enough evidence to proceed. There is no direct evidence as to who drank the alcohol shown on the receipts provided by Mr. Oberholzer.

Authority members discussed the proposed dismissal. Brown moved to accept the dismissal of the show cause order. Machado seconded. All in favor.

D. Show Cause Hearing – Hei Han Enterprises Inc. d/b/a Henry's – Tavern Liquor License – 935 Pine Street – 6/17/19 Incident

Prosecutor Gollin noted he would like to continue this to the October meeting when the penalty is imposed on the other matter with Henry's. Mr. Yen was okay with that.

Brown moved to continue this hearing until the October 28 meeting. Kaufman seconded. All in favor.

F. Show Cause Hearing – por wine house LLC d/b/a por wine house –

Hotel and Restaurant Liquor License – 701 Main Street – 7/6/19
Incident

Chairperson Machado called the show cause hearing to order.

Mr. Gollin, Special Prosecutor for the City stated he was ready to proceed. Patrick Walsh, 1315 Lambert Circle, Lafayette, CO, owner of Por Wine House, stated he was ready to proceed without an attorney.

Machado made the show cause order and notice of the hearing part of the record.

Mr. Gollin waived his opening statement. Mr. Walsh stated as a business owner he takes liquor service to customers very seriously and all his employees are trained in alcohol service as a condition of employment.

Officer Barrett Odenbach, a Louisville police officer, took the oath and reported he was called out to Por Wine House on the evening in question. Dispatch said a neighboring restaurant refused service to a patron and then they saw him walk across the street to Por. Officer Odenbach parked in front of Por. Officer Rogers went to talk to the reporting party. Officer Odenbach saw a man he thought was the patron in question. The man was close to a group of people and was loud and fit the description provided. The patron had what looked like a margarita in front of him. Officer Odenbach had the patron exit the bar to talk to him. His receipt showed one drink, a margarita. The patron showed signs of intoxication and given a breath test showing he was twice over the legal limit. Officer Odenbach took the patron to the addiction recovery center.

Mr. Walsh asked if Officer Odenbach got receipts from Huckleberry. The answer was no. The patron reported being at other establishments but couldn't remember where. Dispatch provided the description of the man and Officer Rogers got further information.

Mr. Walsh noted the precise tip on the tab. Officer Odenbach noted he helped the man finish the receipt before taking him to recovery. Mr. Walsh said an internal incident report was done at Por. Officer Odenbach was not aware of the internal report. The two individuals the patron had been talking to reported he was not bothering them.

Officer Seth Rogers took the oath and noted he is a Louisville police officer and was on duty on the day in question. When the officers arrived on the scene, Officer Odenbach stayed in front of Por and Officer Rogers went to the Huckleberry. Rogers spoke to the server who had called the police. The server reported the patron was acting oddly and was refused alcohol service and then observed going across to Por. The server at Huckleberry pointed the individual out in Por across the street.

Officer Rogers went across to Por and watched to make sure everyone was safe. Members of Huckleberry staff indicated which patron was the individual who was refused service at their establishment. Officer Odenbach assisted the patron with his receipt. Officer Rogers determined the server's name at Por by looking at the patron's receipt.

The bartender and the owner of Por spoke to Officer Rogers. The bartender reported she did not think the patron was intoxicated to the point to refuse service and was only at the bar a short time before the police took him away.

Mr. Walsh asked about the timing of the incident. Officer Rogers noted he helped get the patron out of the restaurant and came back later to talk to the bartender. He reported the male had been refused service across the street and issued a ticket to Por's bartender for serving to an intoxicated person.

Mr. Walsh was sworn in and noted he was brought into the aftermath of this incident. Officer Rogers came later in the evening and wanted to speak to the bartender. Mr. Walsh did not hear the bartender say the individual was intoxicated. She reported he sat down without incident, she gave him water and a menu. The patron ordered and talked to surrounding individuals. The margarita was set down in front of him and it was only three minutes according to their point of sale system until he was pulled away from the bar by the police. Mr. Walsh said the individual did not display any signs of intoxication to his staff. The patron got up, went with the officers and had a civil conversation. Mr. Walsh noted his staff is thoroughly trained and very aware of the policies concerning alcohol service.

Mr. Gollin asked if Mr. Walsh saw this patron come into the bar. Mr. Walsh said he was inside the restaurant he did not see the man come in and noted the patron was on the front outdoor patio area and there was nothing to alert him to any problem with this individual.

Machado asked if Mr. Walsh was present during the officer's entire discussion with the bartender. Mr. Walsh reported he was and said the bartender did not say the patron was intoxicated.

Mr. Gollin presented his closing statement.

Mr. Walsh presented his closing statement.

Machado closed the hearing and called for questions and deliberation from the Authority.

Brown found it difficult to believe a patron observed as intoxicated in one establishment was not observed as intoxicated in another.

Machado noted he appreciates what Mr. Walsh does to prevent over service but found the bartender's statement as reported in the police report problematic.

Kaufman wondered if the bartender should have further engaged this patron to determine if he was intoxicated.

MOTION: Brown moved sufficient evidence had been presented to support the charges stated in the Show Cause Order concerning a visibly intoxicated person and that the Authority Attorney be directed to prepare a draft of final findings, conclusions and an order for consideration at the Authority's next meeting to be held on October 28, 2019 and further moved to continue this matter until that time. Kaufman seconded. Roll Call Vote: Brown – yes, Kaufman – yes, Machado – yes.

Mr. Gollin recommended the penalty be 3 days suspension with 2 days held in abeyance and the ability to pay a fine in lieu for 1 day.

Machado moved to accept the recommendation for 3 day suspension, 2 days held in abeyance and allow a fine in lieu for the 1 day figured at 20% of liquor sales, no less than \$200 and no more than \$5000, on October 5, 2019 and report and pay the fine by October 21, 2019. Kaufman seconded. All in favor.

Members discussed the fine in lieu and determined Mr. Walsh could report his information to the Authority Secretary and have her figure the fine and accept it from Mr. Walsh.
