**FINDINGS OF FACT, CONCLUSIONS OF LAW, AND FINAL DECISION AND ORDER**

**I. Introduction.**

A. This matter came before the Local Licensing Authority of the City of Louisville, Colorado (“Authority”) pursuant to an investigative report and summons and complaint filed by the City of Louisville Police Department with the Secretary of the Authority, relating to an incident occurring on October 15, 2019, at Miles Sports Pub & Grub.

B. By order dated November 25, 2019, the Authority ordered the Licensee to appear at a hearing and show cause why its liquor license should not be suspended or revoked for violation of one or more of the following laws, regulations or ordinances:

1. Section 44-3-9-1(1)(a), Colorado Revised Statutes (C.R.S.);
2. Section 47-900.A, Colorado Code of Regulations (C.C.R.); and
3. Section 9.22.060, Louisville Municipal Code (“LMC”).

C. The hearing was opened on January 27, 2020, and continued until Monday, February 24, 2020.

D. The hearing was held on Monday, February 24, 2020. Authority members Carlson, Machado, Newell, and Kaufman were present. Appearing for the City was Adam Gollin, Esq. Appearing for the Licensee was Jonathan Malone-McGrew.

E. Liaison to the Authority, Patrol Sergeant Benjamin Redard and Officer Don Adam of the Louisville Police Department appeared at the hearing and gave testimony at the request of the City. Jonathan Malone-McGrew gave testimony on behalf of the Licensee.

F. After establishing an evidentiary foundation, the City showed select clips of body camera footage from police who responded to the incident, which showed the officers' contacts with Casey Dockstader, Melissa Murr, and Jessica Martinez.

G. Mr. Malone McGrew showed footage from Miles Sports Pub & Grub's video surveillance system, which showed Mr. Dockstader at the bar with Ms. Martinez, and Mr. Dockstader's head down on the bar after Ms. Martinez left.

H. Both the body camera and surveillance footage was admitted by the Authority into the hearing record.

## **II. Factual Background and Findings.**

A. Miles Sports Pub, Inc. holds a hotel and restaurant license. Its licensed premises are located at 328 McCaslin Boulevard in Louisville, Colorado, where it operates Miles Sports Pub & Grub.

B. Corporal Gabe Romano responded to 328 McCaslin Boulevard in reference to a drunk person at approximately 10:02 PM on October 15, 2020. (Exhibit A to Order to Show Cause, hereinafter "Romano's Report".)

C. When en route, Corporal Romano was relayed a description of a male wearing a black shirt and green hat given to Boulder County Dispatch by Melissa Murr, the reporting party and an employee of Miles Sports Pub & Grub. (Romano's Report.)

D. Upon arrival, Officer Romano and Officer Adam contacted a male matching the description who they later identified as Casey Dockstader. (Romano's Report.)

E. According to Romano's Report, Mr. Dockstader was standing in the doorway of Miles Sports Pub & Grub and appeared to be yelling at the staff inside, before he shut the door and began walking away from the business, whereupon Corporal Romano observed that Mr. Dockstader looked "very unsteady on his feet." (Romano's Report.)

F. Officer Adam testified that Mr. Dockstader displayed signs of intoxication, including balancing issues and heavy odor of alcohol, which due to Officer Adam's training, led him to conclude Mr. Dockstader was intoxicated. (Adam Testimony.)

G. Corporal Romano and Officer Adam then detained Mr. Dockstader "for his own safety, based on his level of intoxication and the safety of Officers." (Romano's Report; Adam Testimony)

H. Sergeant Redard arrived sometime after Mr. Dockstader was detained. (Redard Testimony.)

I. Sergeant Redard observed that Mr. Dockstader was slurring his words and giggling a lot, and concluded, in accordance with his training, that Mr. Dockstader was intoxicated. (Redard Testimony.)

J. Corporal Romano then proceeded inside Miles Sports Pub & Grub to speak with Ms. Murr, the reporting party. (Romano's Report.)

K. Ms. Murr advised that Mr. Dockstader showed up to the Miles Sports Pub & Grub and was having drinks with a female later identified as Jessica Martinez. (Romano's Report.)

L. Ms. Murr further advised that Mr. Dockstader had told her to put Ms. Martinez's drinks on his bar tab. (Romano's Report.)

M. Mr. Dockstader and Ms. Martinez ordered three lemon drop shots, three Modelo beers, and one Vegas bomb shot, for a total of \$34.75. (Romano's Report; Body Camera Footage.)

N. Ms. Murr observed Mr. Dockstader being very friendly with Ms. Martinez, and shortly thereafter Ms. Martinez left Miles Sports Pub & Grub and walked over to Centennial Wine and Spirits, her place of employment, which Ms. Murr surmised was done in order to get away from Mr. Dockstader. (Romano's Report; Body Camera Footage.)

O. After Ms. Martinez left, Mr. Dockstader put his head down on the bar and became uncooperative with Ms. Murr about paying his tab. (Romano's Report.)

P. Ms. Murr then called the police after kitchen staff overheard the interaction and intervened. (Body Camera Footage.)

Q. Never did the interaction between Miles Sports Pub & Grub staff and Mr. Dockstader become physical. (Romano's Report.)

R. After speaking with Ms. Murr, Corporal Romano then contacted Ms. Martinez at Centennial Wine and Spirits, who advised that Mr. Dockstader arrived at the bar after she had and that he appeared already intoxicated. (Romano's Report.)

S. Ms. Martinez further advised that after having a few drinks with Mr. Dockstader, she felt the date was going badly, so she had her coworker text her so that she could leave the situation. (Romano's Report.)

T. Corporal Romano then responded back to Miles Sports Pub & Grub to speak with Ms. Murr a second time. (Romano's Report; Body Camera Footage.)

U. Ms. Murr advised that in the beginning Mr. Dockstader was coherent and did not appear to be extremely intoxicated. (Romano's Report; Body Camera Footage.)

V. Ms. Murr further advised that Mr. Dockstader had two lemon drop shots and Ms. Martinez had three beers and a lemon drop shot. (Romano's Report.)

W. Mr. Dockstader and Ms. Martinez then went outside for approximately ten minutes before returning. (Romano's Report.)

X. After Ms. Martinez left Miles Sports Pub & Grub, Mr. Dockstader ordered a Vegas bomb. (Romano's Report.)

Y. Ms. Murr asked Mr. Dockstader if he was driving and he responded that he would be getting an Uber or Lyft. (Romano's Report.)

Z. Ms. Murr told Mr. Dockstader that she would give him the Vegas bomb, but that he would have to pay the tab after that. (Romano's Report.)

AA. Ms. Murr recounted an experience of hers wherein an intoxicated person had been hit by a car after leaving another bar at which she had worked in the past. (Body Camera Footage.)

BB. Ms. Murr advised that she knew that if she did not serve Mr. Dockstader, he would leave, and she did not want Mr. Dockstader in the road. (Redard Testimony.)

CC. Ms. Murr further advised that Mr. Dockstader's speech become very slurred after consuming the Vegas bomb.

DD. Mr. Malone-McGrew challenged whether the evidence in the record credibly established whether Mr. Dockstader was visibly intoxicated at the time he was served with alcohol.

EE. The City's Special Prosecutor urged the Authority to exercise common sense.

### **III. Applicable Law.**

A. C.R.S. § 44-3-901(1)(a), stating in pertinent part that it is unlawful for any person to "sell, serve, give away, dispose of, exchange, or deliver or permit the sale, serving, giving, or procuring of any alcoholic beverage to a visibly intoxicated person or to a known habitual drunkard."

B. Colorado Code of Regulations, Regulations Relating to Alcohol Beverages § 47-900.A, stating in pertinent part that the licensee as well as any employee or agent of licensee "shall conduct the licensed premises in a decent, orderly and respectable manner, and shall not serve a known habitual drunkard or any person who displays any visible signs of intoxication, nor shall they permit a known habitual drunkard or any person who displays any visible signs of intoxication to remain on the premises without an acceptable purpose . . .".

C. Louisville Municipal Code § 9.22.060, stating in pertinent part that no person “shall sell, serve, give away, dispose of, exchange or deliver, or permit the sale, serving, giving away or procuring of, any alcohol beverages, as defined in section 9.22.010...to a visibly intoxicated person, or a known habitual drunkard.”

**IV. Violations Established at the Hearing.**

A. The Authority finds, by a preponderance of the evidence, that Licensee violated Section 44-3-9-1(1)(a), Colorado Revised Statutes (C.R.S.); Section 47-900.A, Colorado Code of Regulations (C.C.R.); and Section 9.22.060, Louisville Municipal Code (“LMC”).

B. While the Authority finds that Licensee violated the above-cited laws and regulations, the Authority also finds that Licensee’s employee, Melissa Murr, acted in good faith under the circumstances.

C. The Authority further finds Melissa Murr’s good faith actions to be a mitigating factor, and that the penalty for the violations should be minimal.

**V. Order.**

At the conclusion of the hearing, upon motion made, seconded and duly adopted, the Authority found the Licensee violated the laws listed in IV.A, above.

At the Authority meeting held on February 24, 2020, this matter was reconvened and the parties were permitted to give testimony in the nature of mitigation and/or aggravation. The Authority has taken such testimony into account in imposing the suspension set forth below.

Based on the findings of fact and conclusions of law as set forth herein, it is hereby ORDERED that the Licensee’s tavern liquor license be suspended for a period of three (3) days. The three (3) day suspension will be held in abeyance, provided that the Licensee is not found to have violated the Colorado liquor statutes or regulations or the Louisville Municipal Code for a period of one (1) year from the date of this Order. If Licensee is found by the Authority to have violated the Colorado liquor statutes or regulations or the Louisville Municipal Code within the one (1) year abeyance period, the Authority may require the Licensee to serve all or part of the three (3) day suspension on dates as determined by the Authority.
